Cement Masons and Plasterers 401(k) Plan

Increase in Plan-Related, Non-Recordkeeping Costs

The monthly fee for certain 401(k) Plan-related costs increased from \$6.67 per month to \$10.17 per month effective August 1, 2024. This change will first be reflected on your September 30, 2024 monthly statement.

The Cement Masons and Plasterers 401(k) Plan is a relatively new plan and this increase in the fee is the result of the Trustees determining the correct fee amount for the Plan based on anticipated expenses. In consultation with its advisors, the Board of Trustees determined that it is now necessary to increase the non-recordkeeping fee to pay for ongoing fund office and advisor costs that have evolved since the Plan's establishment in 2022.

The recordkeeping fee will remain at \$5.33 per month.

The Plan's Board of Trustees will continue to review these fees and will adjust the fees in the future if necessary.

Background on Plan Costs

Plan costs are passed through to all participants in the Plan and fall into two basic categories:

- Investment-related costs charged by the fund managers that operate the investment funds offered by the Plan; and
- Plan-related costs, including the "recordkeeping costs" (Milliman), and "non-recordkeeping costs"— the Fund Administrative Office, and Plan advisors and accountants and other operational expenses such as printing, mailing costs and technology.

<u>Investment-related costs</u>. Fund managers charge for their services by taking a percentage of assets as their fee. This charge is called the "expense ratio" and compensates the manager and reimburses certain investment-related operational costs. The investment fund's investment return credited to your account is net of the expense ratio.

One of the Plan's investment managers rebates a portion of their fee. This portion is called "revenue sharing." Where it applies, "revenue sharing' is collected by Milliman and then credited back to the participants that have selected that investment manager. This occurs on a quarterly basis.

<u>Recordkeeping costs</u>. Recordkeeping fees are applied monthly and debited against accounts at a charge of \$5.33 to each participant and beneficiary account in the plan. This fee is staying the same.

<u>Non-recordkeeping costs</u>. Other Plan-related costs also applied monthly and are debited against accounts by a monthly charge of \$10.17 to each participant and beneficiary account. This fee was increased from \$6.67 per month effective August 1, 2024.
